03	Construction of Civil block building.	Application has been made for the construction of a new block connecting the Existing J.S. Block and Poojya Sri Rajaji block to accommodate the academic activities of the Civil Department.
04	NIRF Ranking.	The institute has a better performance compared to the previous year. As per the report presented by the Head of the institution, it has been decided to concentrate on the relevant areas pointed out in the Principal's Report.
