Siemens Centre of Excellence in Manufacturing hereinafter called the "Siemens CoE or CoE" functioning in National Institute of Technology, Tiruchirappalli, a premier academic Institution of International repute incorporated under National Institute of Technology Act, 2007 having its permanent campus and office at Tanjore main road, National Highway 67, near BHEL, Tiruchirappalli, Tamilnadu 620015 (hereafter referred to as 'NIT Trichy', which expression shall include its successors and assigns) of the first part;


And

Saranathan College of Engineering, Tiruchirappalli hereinafter called the "SCE" (which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and assigns) of the second part;

WHEREAS:

1. The National Institute of Technology (formerly known as Regional Engineering College) Tiruchirappalli, situated in the heart of Tamil Nadu on the banks of river Cauvery, was started as a joint and co-operative venture of the Government of India and the Government of Tamil Nadu in 1964 with a view to catering to the needs of man-power in technology for the country. The college has been conferred with autonomy in financial and administrative matters to achieve rapid development. Because of this rich experience, this institution was granted Deemed University Status with the approval of the UGC/AICTE and Govt. of India in the year 2003 and renamed as National Institute of Technology, thereafter.
2. Siemens CoE established in 2018 at NIT, Trichy premises with 90% investment from Siemens and 10% investment from NIT, Trichy. The CoE operates with a primary objective of creating a robust technical education eco-system through its experience in industrial products and services. 6. Details of Institute

Saranathan College of Engineering was founded by "Vidya Seva Ratnam", "Guru Seva Mani" Auditor Sri. K. Santhanam in the year 1998. It was so named in respectful memory of his Guru Principal Saranathan, the greatest ever Principal of National College, Tiruchirappalli. It is a self-financing college approved by AICTE and affiliated to Anna University, Chennai. The college is located in sprawling 40-acre campus on the Chennai – Madurai Expressway at Panjappur, Tiruchirappalli - 12. The college has a current annual intake of 660 students for the 7 branches offered at the undergraduate level and 114 students for the 4 courses offered at the post-graduate level. CSE, EEE, ECE and Mechanical departments are permanently affiliated to Anna University, Chennai. All the eligible 6 UG branches are accredited by NBA, New Delhi.

The Siemens CoE, National Institute of Technology, Tiruchirappalli, India enters into the following Agreement to offer Skill Development, Training and other related services to Saranathan College of Engineering.

1. Siemens CoE offers various skill development courses across different disciplines Saranathan College of Engineering committed/commits to send 100 number of students/faculty every year for such courses. The timing/duration of the courses shall be arrived on mutually agreed dates. The CoE offers 20-40% discount on the regular advertised course fee depending on the demand.
2. A student/faculty who has completed any CoE offered courses will be given 10 Hours of free Lab usage time after the course within one-year duration. The timing will be decided by the CoE based on the availability.
3. Siemens CoE offers the resources for student projects on chargeable basis. It is the responsibility of the faculty mentor from Saranathan College of Engineering to monitor the progress. The CoE shall not offer any certification for such usage but shall provide an attendance certificate.
4. Siemens CoE offers Internships to students. The CoE can accommodate a reasonable number of students depending on the demand.

5. The faculty of Saranathan College of Engineering shall submit funding/consultancy proposals quoting the Siemens CoE resources. In such cases, a NITT faculty will be the Co-PI and budgeting need to be arrived through mutual discussion before submission.
6. Siemens CoE periodically conducts workshops/symposiums/conferences etc. For such events, any participant from Saranathan College of Engineering will get 25% discount on the Registration fee.
7. Saranathan College of Engineering shall organize events such as workshops/symposiums/conferences jointly with Siemens CoE. In such cases, the financial implications need to be discussed and to be approved by competent authorities before the event.
8. Siemens CoE will not be responsible for safety of the students outside the NITT premises. Saranathan College of Engineering should instruct their students clearly on the safety and precautionary measures.
9. Siemens CoE will not be responsible for loss/theft or damage of any of the student's belongings. Saranathan College of Engineering should instruct their students clearly on the precautionary measures.
10. The implementation of specific activities will be separately agreed between both institutions on need basis.
11. Other terms and conditions which are not provided in this Agreement will be deliberated and agreed upon by the institutions hereto.
12. This Agreement is established in English language and is valid from the date of signing by the representatives of the institutions. The institutions hereto have executed this Agreement in duplicate, and each institution shall keep one copy of the originals.
13. This agreement shall be governed by and construed in accordance with the laws of India.
14. The two parties will consult each other and attempt to resolve disputes or misunderstandings that arise in the administration of this agreement informally.
15. This agreement shall be valid for a period of three years from the date both signatures are affixed to this document or before if terminated by mutual agreement of both. This agreement may be terminated by either party after one hundred and twenty (120) days following receipt of a written notification of intent to terminate by the other party.
16. If a proposal to renew this agreement is not presented before the end validity period, it will be terminated automatically at the end of three years.

- Sara-ECE shall nominate faculty in-charges to prepare MODROBS proposals in association with the expert from your end.



This MOU is non-binding and shall be valid for a period of 5 years (renewable) from the date of execution of until exchange of correspondence as aforesaid whichever earlier is later.

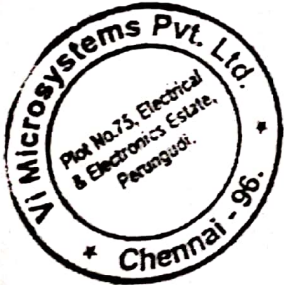



Memorandum of Understanding

Analog Teaching Lab Setup at Saranathan College of Engineering, Trichy..

This memorandum of understanding is signed on the 17 day of NOVEMBER, 2012, between the following institutions:

- a. Cranes Software International Limited, Bangalore (referred to as Cranes henceforth) which is University Program Partner of Texas instruments ,India
- b. Saranathan College of Engineering, Trichy.

This Memorandum of Understanding is proposed in order to establish a teaching/research lab facility using ASLK Starter Kits at Saranathan College of Engineering, Trichy.

Through this Memorandum of Agreement, the two parties agree to the following.

- (a) A steering committee will be set up to monitor the activities of the MoU. The committee will consist of the Executive Director of Cranes Varsity (a division of Cranes Software), and the Principal of Saranathan College of Engineering, Trichy. With mutual consent, the steering committee can be expanded to include more members from the two institutions. The steering committee will be the supreme body as far the implementation of the activities of the MoU, the continuation of the MoU, and termination of the MoU are concerned.
- (b) Lab Setup: The College will set up a lab which will be entitled "Texas Instruments Analog Systems Lab". For the purposes of this Agreement, the party that discloses Confidential Information to the other party shall be referred to as the "Disclosing Party", and the party that receives such Confidential Information from the other party shall be referred to as the "Recipient".

The Recipient may be given access to the Disclosing Party's Confidential Information or to create new Confidential Information for the Disclosing Party.

In view of the above, the parties agree as follows:

1. Confidential Information

"Confidential Information" includes any information:

- specifically indicated by the Disclosing Party, either verbally or in writing, as confidential;
- under the circumstances of the disclosure, that are to be treated as confidential; or
- the Recipient creates or produces while performing its obligations under this Agreement, regardless of the media that contains the information.

Confidential Information does not include information, which:

- is generally available to the public at the time of its disclosure to the Recipient;

- becomes known to the public through no fault/action of the Recipient in violation of the terms herein;
- is legally known to the Recipient at the time of disclosure by the Disclosing Party;
- is furnished by the Disclosing Party to third parties without restriction; or
- is furnished to the Recipient by a third party who to the Recipient's knowledge legally obtained said information and the right to its disclosure.
- is developed independently by Recipient without use of or reference to the Disclosing Party's information.

2. Restrictions on Use

- (a) The Recipient will not disclose any Confidential Information to third parties for any purpose without the prior written consent of the Disclosing Party. However, where the Recipient is required to disclose Confidential Information in accordance with judicial or other governmental action, the Recipient will give the Disclosing Party reasonable prior notice unless such notice is prohibited by applicable law.
- (b) The Recipient will not use any Confidential Information for any purposes except those expressly contemplated or authorized by the Disclosing Party.
- (c) The Recipient will take the same reasonable security precautions as it takes to safeguard its own confidential information, but in no case less than reasonable care.
- (d) The Recipient undertakes to impose the confidentiality obligations on all directors, officers and employees or other persons who work for the Recipient or under its direction and control, and who will have access to the Confidential Information.
- (e) The Recipient will return all originals, copies, reproductions and summaries of Confidential Information in its control, or confirm its destruction as requested by the Disclosing Party.

3. Action on Breach

- (a) The Recipient will notify the Disclosing Party immediately upon discovery of any breach of this Agreement by the Recipient, and will cooperate in every reasonable way to help the Disclosing Party regain possession of the Confidential Information and prevent further breach.
- (b) The Disclosing Party will be entitled, without waiving any other rights or remedies, to seek such injunctive or equitable relief as may be deemed proper by a court of competent jurisdiction.

4. Ownership and Warranties

- (a) All Confidential Information, including the inherent intellectual properties, remains the sole and exclusive property of the Disclosing Party and the Recipient shall have no right, title or interest in the same. Similarly, the Disclosing Party does not own any of the intellectual property of the Recipient, including any proprietary methodologies, tools or practices, unless otherwise agreed.
- (b) The Disclosing Party, unless expressly confirmed, makes no warranty regarding the accuracy or reliability of Confidential Information.

5. Applicability of Provisions

- (a) The provisions of this Agreement are jointly and severally applicable and will not be considered waived by any act or acquiescence, except by a specific prior written confirmation. Accordingly, both parties will expressly agree in writing to any changes in the Agreement.
- (b) If any provision of this Agreement is held illegal, invalid or unenforceable by law, the remaining provisions will remain in effect. Moreover, should any of the obligations of this Agreement be found illegal or unenforceable for any reasons, such obligations will be deemed to be reduced to the maximum duration, scope or subject matter allowed by law.
- (c) If any action at law or in equity is necessary to enforce or interpret the rights arising out of or relating to this Agreement, the prevailing party shall be entitled to recover reasonable attorney's fees, costs and necessary disbursements in addition to any other relief to which it may be entitled.

6. Jurisdiction

This Agreement will be governed by the laws of India on all substantive aspects, and both parties consent to the jurisdiction of the courts in Bangalore.

7. Tenure and Survival

All obligations created by this Agreement shall survive change or termination of the parties' business relationship for a period of two years from the date of the disclosure of the Confidential Information or the change in/termination of the business relationship of the parties whichever is later.
