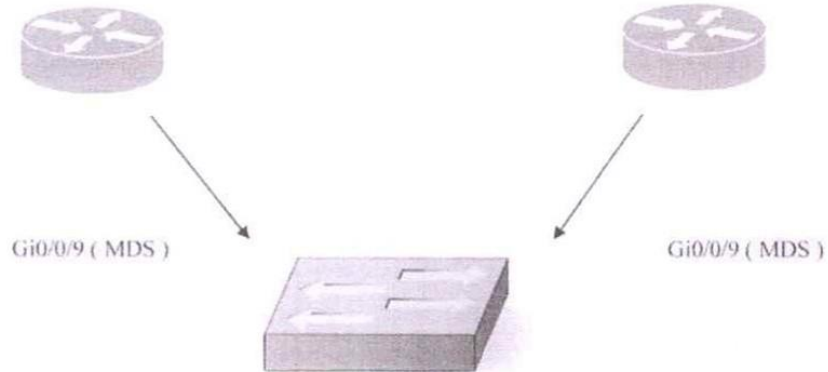
Customer Network Diagram

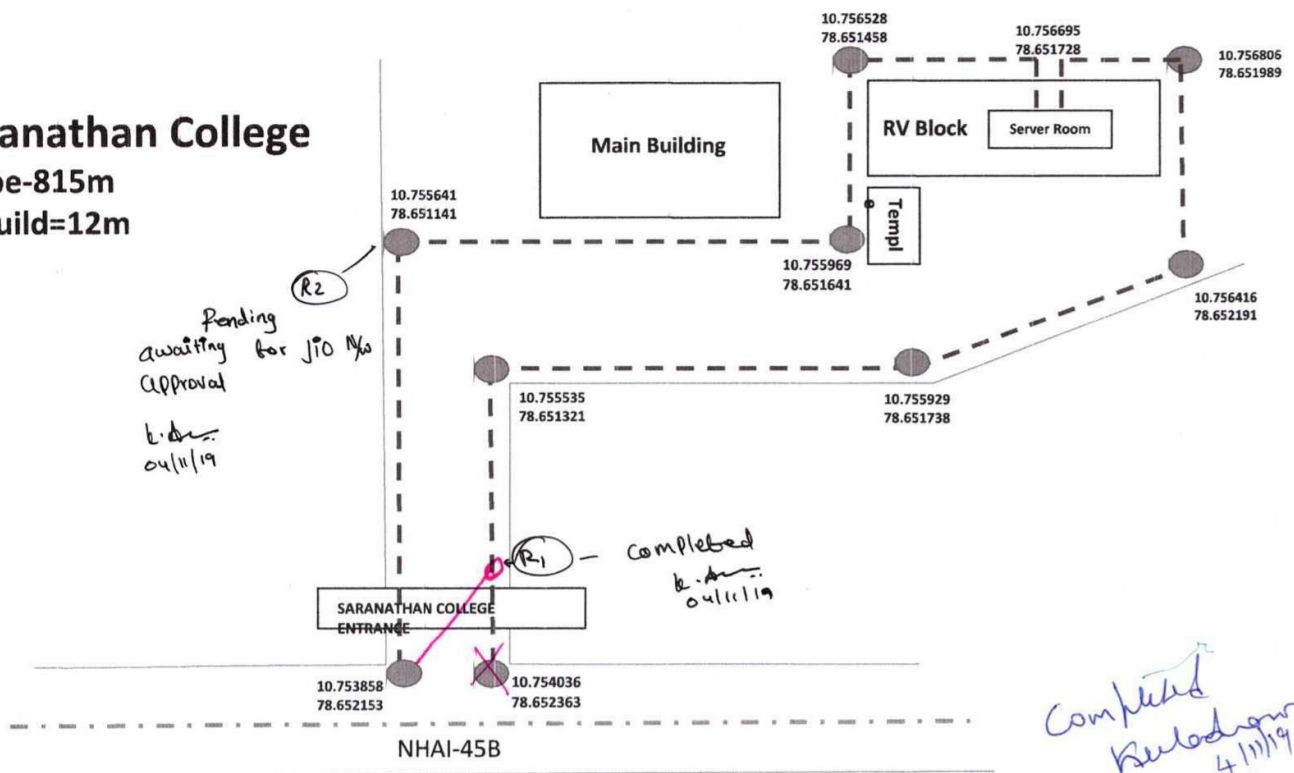

In this regard we received quotations from Reliance Jio, BSNL and Channel Nine. The following table shows the comparison of various Internet Service Providers.

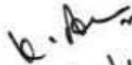
